#### Confirmation of the minutes of the previous meeting:

Dave moved to accept the previous minutes and Mark seconded their acceptance.

#### Business arising from the minutes:

1. Trailer fundraising  
**Andrew L** to investigate buying PowerBars. Staminade drink powder investigated by Andrew but deemed not suitable at 1000 tubs per crate the only purchase option.  
Further investigations to be made re: upgrading trailer. New quotes to be sought for purchasing new trailer v brake fitting.
2. Club Uniforms  
Alison has the shirts and is distributing them to those who ordered one.  
T-shirt City may have difficulty in printing "Tribe" on lycra e.g. Bathers, race suits. Sports Wear can print 20 items minimum, \$66 set up fee + \$5.50 per garment. **Resolved** to email members and ask for any items by end of the month, cost \$10.00 per garment. **Alison** to be hills collector (garment and money) and **Asha** the town collector.
3. Swimming at the Army Barracks  
Approx 17 -19 members paid up. Need 23 to break even. Pool membership to be encouraged by all.
