I, the undersigned in consideration of & as a condition of acceptance of my entry in the Tribe Triathlon Club event, for myself, my heirs, my executors & administrators, hereby waive all & any claim, right or cause of action which I or they might otherwise have for, or arising out of, loss of my life or injury, damage or loss of any description whatsoever which I may suffer or sustain in the course or consequent upon my entry or participation in the said event. 7.
